The **Joint Director, Flood Management Improvement Support Centre, Jal Sansadhan Bhawan, Anisabad, Patna** now invites online proposals to provide the following consulting services (hereinafter called "Services"): for Implementation and Assessment of State Water Reforms Framework (SWRF) Indicators and Establishment, Operation and Maintenance (O&M) of Bihar State Water Informatics Centre (B-SWIC). More details on the Services are provided in the Terms of Reference. However, registration with the Water Resources Department, Government of Bihar, will be essential within one (1) Week after the issue of the Letter of Acceptance (LoA) for the service in concern.
2. A firm will be selected under **Least-Cost Selection (LCS)** procedures and in a Full Technical Proposal (FTP) format as described in this RFP, in accordance with the provision of bid document.
3. The firm may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. Number of partners in a JV shall be **limited to two including the lead partner**.
4. The Bid Processing fee as indicated in the table below and cost of the Bid Document (Non-refundable) must be paid online, i.e., through Internet Payment Gateway (Credit Card/ Debit Card), Net Banking, NEFT/ RTGS (Payment documents are to be submitted as per the procedure described in **paragraph 6** below, if so specified therein). Consultant will be required to register on the website. The Consultant would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
5. All Bids must be accompanied by a Bid Security of the amount specified for the Consultancy Services in the table below, drawn in favour of **Joint Director, Flood Management Improvement Support Centre, Jal Sansadhan Bhawan, Anisabad, Patna** Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
