 - [i] High Cost-effectiveness: Low life-cycle cost with low-to-very-low maintenance, easy repair ability and high performance reliability.
 - [ii] High Performance Efficiency as a System: Should blend with the natural environment and improve performance and efficiencies of current practices.
 - [iii] Environmentally Friendly: Should not harm the environment and should support the growth of ecological balance.
 - [iv] High Durability: Should be highly durable while retaining the desired performance standards against degradation due to physical, chemical or biological effects.
 - [v] Enhanced Use of Local Resources: Should support use of locally available resources and manpower without compromising on the engineering aspects of the structures.
 - [vi] Proven Performance Standards: Should have proven performance records in India or abroad in the last 10 years or so.
 - [vii] Scalability & Versatility of Usage: Should be adaptable to various prevailing and unforeseen ground conditions and be easily available with least procurement time so as to meet the evergrowing requirements of the sector.
 - [viii] Shortest Construction Time: Considering the need for faster infrastructure development, the products/technologies should support shortest construction time and preferably be weather-proof.
- (B) Required Documents: The agency should submit the following documents along with its expression of interest:
 - Approach and Methodology: Should include complete approach, methodology and technology for installation along with its complete design supported with research, technical specification etc.
 - [ii] Durability Performance: It should be supported by laboratory reports, brochure, bulletin etc.
 - [iii] 3rd Party Evaluation: The performance of the products/services must be supported by a third party evaluation/audit report.
 - [iv] Rate: Submission of involved relevant component wise rates of above mentioned work must be in per running metre, square metre, cubic metre etc. and also along with their finished rates.
 - [v] Work Experience: The firms should attach documents depicting execution of mentioned work along with places in India or abroad or both.
 - [vi] Work Completion Certificate Issued by Employers: The firm should attach employer's certificate issued for previous works done in said fields.



- (C) Presentation and Demonstration: The agency may be asked to present the following:
 - Power Point Presentation: Arrange Power point presentation of their proposal in front of official [i] of WRD.
 - Physical Demonstration: Selected proposal/s may be asked to make physical demonstration at iii selected work site(s) in limited area at their own cost.
