The Government of India has received a credit of US\$ 250 million equivalent from the International Development Association (IDA) towards the cost of Bihar Kosi Basin Development Project and it is intended that part of the proceeds of this credit will be applied to eligible payments under the contracts for which this invitation for Bids is issued.
2. The Executive Engineer, Punpun Flood Protection Division, Water Resources Department, Anisabad, Patna on behalf of **Governor of Bihar** now invites Bids under e-procurement system (Two Parts) from eligible bidders for Supply, Installation, Testing, & Commissioning of Computer System for Mathematical Modelling Centre (MMC), Centre of Excellence (CoE) at 2nd Floor, Jal Sansadhan Bhawan, Anisabad, Patna, Bihar as per table below

3. The eligible Bidders may submit bids for any or all of the Lot consisting of equipments mentioned above. Bidders are advised to note the eligible criteria as given in ITB Clause 4 & 5 and qualification criteria specified in Section III to qualify for award of the contracts. The Bidders are required to submit bids consisting of documents/information as specified in clause 11 of ITB.
4. Bidding documents are available online on <https://eprocure.gov.in/> from **30/08/2017** to **22/09/2017** for a non-refundable fee as indicated in the table, in the form of Demand Draft on any Scheduled/Nationalized Bank payable at Patna in favour of **Executive Engineer, Punpun Flood Protection Division, Water Resources Department, Anisabad, Patna, Bihar, PIN-800002** (Demand Draft to be submitted subsequently as per the procedure described in paragraph 6 below). Bidders will be required to register in the website, which is free of cost. The bidder would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
5. **Bid Security:** Bid security of the amount specified for the works/Lots in the table above, drawn in favour of **Executive Engineer, Punpun Flood Protection Division, Anisabad, Patna, Bihar, PIN-800002** needs to be submitted as per the procedure described in paragraph 6 below. Bid security will have to be in any

one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Bids must be submitted on <https://eprocure.gov.in/> on or before **16:00 hours** on **22/09/2017** and will be opened online on the **26/09/2017** at **16:00 hours**. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered.

6. **Availability of Bid Document and mode of submission:** The bid document is available online and bid should be submitted separately for each lot online on website <https://eprocure.gov.in/> only. The bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e tendering may obtain the same from the website: <https://eprocure.gov.in/>. Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender. Bids submitted in any other manner will not be accepted. Bidders are required to obtain Level III Digital signature from designated firms (available on e-proc. Portal and then register with the centralized e - Procurement Portal i.e. <https://eprocure.gov.in/> and submit bids by using their user ID and Digital Signature.
7. **Submission of Original Documents:** The bidders are required to submit following documents in original which should be received by the **Executive Engineer, Punpun Flood Protection Division, Anisabad, Patna, Bihar, PIN-800002** on or before the date/time fixed for opening of technical qualification part of the Bid (Part I of Bid), failing which the bids shall be declared non-responsive.
- (a) Original demand draft towards the cost of bid document;
- (b) Original bid security in approved form specified in the bidding document valid up to 45 days beyond the validity of the bid
- (c) Original affidavit regarding correctness of information furnished with bid document as per provisions of Evaluation and Qualification Criteria Clause 3, Note-2.
- (d) Authorization letter from bidder for the person who will participate at the time of opening of the bid.
- Note:** - *If the office happens to be closed on the date of opening of the bids as specified, the said original documents shall reach the designated officer at the same time on the next working day.
In case of failing in submission of above (a) & (b) before deadline, bidder will be declared non-responsive.*
8. **Pre Bid Meeting:** A pre bid meeting will be held on **11/09/2017** at **11:00 AM (IST)** at the Office of the Joint Director, Flood Management Improvement Support Centre, Anisabad, Patna-2, headed by the Chief Engineer, Flood Control & Drainage, Water Resources Department, Patna, Bihar to clarify the issues and to answer – questions on any matter that may be raised at the stage as stated in clause 7.2 of ‘Instruction to Bidders’ of the bid document. Bidders are advised to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
9. Other details can be seen in the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidder’s responsibility to verify the website for the latest information related to the tender/bid
