Bidding is open to all eligible bidders as defined in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, revised July 2014.Bidders from India should, however, be registered with the Government of Bihar or other State Governments/Government of India, or State/Central Government Undertakings. Bidders from India, who are not registered as above, on the date of bidding, can also participate provided they get themselves registered by the time of contract signing, if they become successful bidders. Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum Evaluation & Qualification Criteria (Section III Evaluation and Evaluation & Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 1.6 and 1.7 of the World Bank's Guidelines setting forth the World Bank's policy on conflict of interest.

Bidders will be required to register in the website, which is free of cost. The bidder would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.

- **4. Bid Security:** Bid security of the amount specified for the work in the table above, drawn in favour of *Executive Engineer*, *Punpun Flood Protection Division*, *Anisabad*, *Patna*, *Bihar*, *PIN-800002* needs to be submitted as per the procedure described in paragraph 6 below. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Bids must be submitted on https://eprocure.gov.in/ on or before 16:00 hours on 28/04/2017 and will be opened online on the 02/05./2017 at 16:00 Hrs. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered.
- **5. Availability of Bid Document and mode of submission:** The bid document is available online and bid should be submitted separately for each package online on website https://eprocure.gov.in/. The bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e tendering may obtain the same from the website: https://eprocure.gov.in/. Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.
- **6. Submission of Original Documents:** The bidders are required to submit following documents in original which should be received by the *Executive Engineer, Punpun Flood Protection Division, Anisabad, Patna, Bihar, PIN-800002* on or before the date/time fixed for opening of technical qualification part of the Bid (Part I of Bid), failing which the bids shall be declared non-responsive.
 - (a) Original demand draft towards the cost of bid document;
 - (b) Original bid security in approved form specified in the bidding document valid up to 45 days beyond the validity of the bid
 - (c) Original affidavit regarding correctness of information furnished with bid document as per provisions of Clause 4.4 B (a) (ii).
 - (d) Authorization letter from bidder for the person who will participate at the time of opening of the bid.
 - **Note**: If the office happens to be closed on the date of opening of the bids as specified, the said original documents shall reach the designated officer at the same time on the next working day.
 - In case of failing in submission of above (a) & (b) before deadline, bidder will be declared non-responsive.
- 7. **Pre Bid Meeting:** A pre bid meeting will be held on 19/04/2017 at 11:00 AM (IST) at the Office of the Joint Director, Flood Management Improvement Support Centre, Anisabad, Patna-2, Headed by the Chief Engineer, Flood Control & Drainage, Water Resources Department, Patna, Bihar to clarify the issues and to answer questions on any matter that may be raised at the stage as stated in clause 7.4 of 'Instruction to Bidders' of the bid document. Bidders are advised to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
