The *Government of India* has been allocated grant funds of *US\$ 0.75 Million* from the *South Asia Water Initiative Multi-Donor Trust Fund (SAWI Grant No. TF0A1269)* toward the cost of the project “*Strengthening Flood Modeling Capacity in Water Resources Department, Government of Bihar*” which are administered by the International Bank for Reconstruction and Development (IBRD) / International Development Association (IDA) and executed by the Flood Management Improvement Support Centre (FMISC), Water Resources Department (WRD), Bihar, Patna.
2. FMISC, WRD, Patna intends to apply part of the proceeds of this grant to eligible payments under the non-consulting services for “**Installation, collection and supply data from Gauge-Discharge Sites in Bagmati-Adhwara Basin**”.
3. The objective is to select locations and install stage/discharge gauge sites, collect stage/discharge data during the consultancy period at specified frequency, and supply such data at specified interval and at end-of-season for use in flood modeling.
4. The Non-Consultancy Services will consist of the following:
 - i) To select and install stage/discharge gauge sites, collect stage/discharge data during the consultancy period at specified frequency, and supply such data at specified interval and at end-of-season for use in flood modeling,
 - ii) To establish site including survey of cross-section at each site, establishing precise location and datum and description, and setting up graduated staff/s for manual observation or sensors with AWLRs/DWLRs. The most-cost-effective solution would be selected, and make necessary logistic arrangements to maintain the sites during 2016 flood season, and to measure/collect stage data, and
 - iii) To conduct discharge measurements through ADCPs or current meters, develop rating curve, observe stage data, convert stage data to discharge, and supply the stage-discharge data every week through the flood season, and the compilation for the whole season
5. The “**Bid Document**” of the above non-consultancy services is uploaded on the website <http://fmis.bih.nic.in> and <http://wrd.bih.nic.in> to assist in the preparation of quotation.
6. The bidders/firms are requested to provide their offer (in sealed envelope) latest by **15:00 Hours (IST) on Wednesday, 08th June 2016** to **Office of Joint Director, FMISC, 2nd Floor, Jal Sansadhan Bhawan, Anisabad, Patna-800002, Bihar, India.**
